

CEV EUROVOLLEY 2026 - WOMEN

DO's and DON'Ts for NON-RIGHTS HOLDERS

In order to protect the exclusive rights of the Broadcast Partners during the **CEV EUROVOLLEY 2026 - WOMEN** taking place in **Türkiye, Czechia, Azerbaijan, Sweden** from **August 21 to September 06, 2026** and provide access for Non-Rights Holders (NRHs), CEV and Infront Sports & Media, the CEV Media Agency, would like to release the following rules that accredited NRHS must respect at all times during the event. Any failure to comply with these rules may result in the withdrawal of the NRH accreditation.

Match Days - Do's and Don'ts - inside the playing arena:

Media representatives with a valid NRH accreditation are **ALLOWED** to:

- Access the media centre, media tribune and mixed zone;
- Film and record audio in the NRH section of the mixed zone.

Media representatives with a valid NRH accreditation are **NOT ALLOWED** to:

- Film at all inside the playing arena on match day*
- Film any match* footage

**For the sake of clarity, each match day is defined as the period starting from the beginning of the warm-up (50 minutes before tip-off) and ending 15 minutes after the final whistle and, in the case of the final match, the end of the awarding ceremony.*

In case of any violation of the NRHs rules, your accreditation will be withdrawn with an immediate effect!

All media representatives with the NRH accreditation must collect a camera sticker from the CEV Press Officer on-site to identify you as an approved NRH and it is valid for the entire event.

Please note that access to the NRHs section of the Mixed Zone is available on a first come, first served basis since the space may be limited.

All the request coming after the deadline will be evaluated and might not be allowed with short notice).

I expressly declare that my activity on-site will not interfere with or jeopardize the activities of the Event Organizers, Athletes, Host Broadcaster and Rights Holders and that I will comply with all applicable guidelines, regulations or communications, written or oral, issued by the Event organizer and/or CEV and/or Infront.

I also acknowledge that the above guidelines, regulations or communications may change at any time at Event organizer's and/or CEV' and/or Infront's discretion and that I will comply with the new instructions that may be provided both in written and/or oral form.

Should I not comply with the above specifications, I am aware that Infront Sports & Media shall take any appropriate legal action to protect its copyrights and proprietary rights and to receive just compensation for any loss and damages suffered.
